 A number of queries were addressed: Referrals (Joan B) – Vicki confirmed that individuals, family members or GP could refer anyone by calling their central numbers. All details can be found here: https://www.lifecare-edinburgh.org.uk/about-lifecare/contact-us/ Trips and Falls (Cllr Osler) – Vicki agreed that they had seen an increase in hospitalisation of older people who had become less mobile and frailer due to lockdown, and that their Help at Home and the Outreach services helped to offer support in these cases. Mike added that an increase in more complex needs and increased frailty was evident in people presenting to health and social care frontline teams. He suggested that the Social Isolation subgroup could help identify locally available Third Sector organisations offering support. 	
Joan added that the poor state of pavements was also a factor in increase of falls.	
LCPP Social Isolation subgroup update	
Mike and Katrina then gave an update of the work of the LCPP Social Isolation Subgroup. The group has representatives from the third sector, NHS, Police Scotland, Fire Scotland and CEC, and their immediate aim is to harness all the good work already going on to reduce social isolation in the locality, and make sure that these activities and services are widely known about and good practice shared. A shared outcomes framework has been developed to allow organisations to see how work they are doing contributes to a shared aim of reducing social isolation, recognising no single organisation or group can achieve this outcome on their own. Mike added that as part of this work, the group is keen to progress the recommendations of NHS Lothian's recent Green Health Prescribing report (<u>www.elhf.co.uk/wp-</u> <u>content/uploads/2021/06/GreenHealthPrescribingReportWeb.pdf</u>) using green health to contribute to Lothian's post COVID recovery. For this reason the group are particularly keen to hear about work going on under the green spaces priority of the Inverleith NN and explore opportunities there to promote health and wellbeing.

	There were a number of comments / queries:	
	 Many people have a perception that Inverleith does not have people living with social isolation, but coupled with a lack of community facilities, it is a real problem which is often overlooked. Mike said that the issue of uneven availability of activities across the locality had been raised by others, and that the subgroup was very aware of this. He suggested that some activities eg walking groups, could be developed in Inverleith. He suggested making contact with eg Spartans or Health in Mind, and then look at funding sources to do this. It is difficult to know what's out there and who to ask. Katrina agreed that raising awareness of services was key and that Western and Almond are both carrying out a mapping exercise of what is on offer post COVID Mike added that the iThrivewebsite is a great resource for finding out what is available and is searchable by postcode. We need to link with the community growing work. John from Arbor Green Nursery extended an invite to any members who would like to see the growing work they do with children and families and are keen to widen into the community. 4. Inverleith NN Priority – Greenspace and	Cllr Barrie explained that a subgroup had been working to bring some identified areas of greenspace to this group to make a decision on which areas to explore further.	
growing	Cllr Barrie summarised the locations identified as initial possibilities based on the map of greenspace that had been circulated:	
	 A) Ferryhill Primary School – he explained that the school was already doing good environmental and growing work with pupils and that they had extensive groups that may be suitable for increased activity. School keen to do some partnership working. B) Wester Drylaw Place – The grassed area behind the Doocot was visited and it is felt that it might be a bigger project than we could start with and might be some time to see progress, so proposed keeping this plot in a bank for future consideration. C) Visited strip of waste land on Cyclepath / walkway behind Crewe Toll Fire Station. It is proposed that this location had more advantages to the Doocot area, and that John leads on this work, which could start with small steps, possibly planting perennials which are hardy and don't need huge amount of care to get flowers each year. 	

	 Alex described the community growing project that had planted fruit trees in several locations across Drylaw. Many fruit trees were vandalised and made project untenable. Whichever is decided it was agreed that community buy in was crucial, and that we must learn from the work that Drylaw Neighbourhood Centre's Growing Project. Drylaw Neighbourhood Centre still have an active garden project in grounds but struggle for volunteers. John added that the latter (c) would be a low risk / low cost proposal and that he could identify some volunteers to work with any interested local people. Katrina suggested that Green Health Prescribing could be one way of connecting local people to green space development work, and as John explained, lots of the outdoor work wasn't too demanding and there were a range of activities/skills used. Alex asked if this site was still earmarked for future tram development. Cllr Barrie to investigate. Susie asked if it might be worth planting wildflowers in a defined area at this location to let people see that it is a positive development before planting trees etc? The group agreed to investigate areas A and C, behind Fire Station. Subgroup members agreed to: To talk to Katrina to explore volunteer recruitment through links with local primary care and the social isolation subgroup as well as identifying own volunteers. Continue dialogue with local parks team to engage with local people and groups To pull together an estimate of start-up costs, taking on board starting small with hardy perennial plants and wildflowers To make renewed contact with Head Teacher at Ferryhill to discuss opportunities 	Katrina to share info Cllr Barrie to investigate tram land ownership John / Katrina to chat John to bring estimate of project costs to be to NN Cllr Barrie to renew contact with Head Teacher.
5. Locality Community Planning Partnership (LCPP) Update	Joan B explained that the LCPP had met and had received presentations on 'Best Value Improvement Plan' and 'Good Place to Live'. The three subgroups also gave an update. 6. Neighbourhood Environment Programme (NEP)	Helen reported that reports had been re-circulated from Roads and Housing Officers but that there was no further update at this time.	
	A report 'Transport Infrastructure Investment - Capital Delivery Priorities for 2021-22' was circulated from the new Transport Infrastructure Team' which would now be managing the NEP projects across the city.	
	This section of the report regarding NEPs and additional comments were highlighted:	
	 4.36 Due to other delivery commitments and the Covid-19 pandemic in 2020/21 there has been very little delivery of Neighbourhood Environmental Projects (NEPs). This has resulted in £1m of NEPs funding being carried forward into 2021/22. 4.37 A programme of outstanding NEPs commitments is currently being developed, using existing funding, with delivery of these projects starting in 2021/22. It is therefore proposed that no additional funding is allocated to NEPs projects in 2021/22. 4.38 A new NEPs allocation will be introduced in 2022/23, primarily based on local traffic management interventions. 	
	The programme of outstanding commitments or schemes is yet to be finalised so we're unable to confirm what sums can be allocated to those schemes previously identified or proposed by the Neighbourhood Network groups, but the situation should become clearer as the competing pressures of Covid-19 pandemic related schemes eases in the weeks and months ahead.
