#### 1. Welcome and apologies

Welcomes and introductions were made as above.

#### 2. Minute of the last meeting and Matters Arising

The note of the previous meeting was approved.

#### 3. South East Locality Improvement Plan

#### Priority 1 (see report for further detail)

Sarah updated the group on Item 3 and highlighted that activities were being stepped up with prioritisation around family and adult-based activities. Dunedin Canmore now restarting on employability actions. Jackie Stewart, Susie Donkin and Ros Papworth met to discuss tracking of the employability work across South East and agreed that a separate update would come to future LCPPs.

Steven acknowledged the strong evidence of partnership work and hoped expects SFRS will do much more once Covid recedes further.

#### Priority 2 (see report for further detail)

Murray explained recent changes to the Chief Inspector and Inspector roles in the South East Locality in Police Scotland. Inspector David Duthie is now taking the lead on the partnership work at Hunter Square. The sub groups of the working group are meeting this week. Peter highlighted that there is a lot of positive work already happening around Hunter Square and partners well engaged.

#### Priority 3 (see report for further detail)

Sarah highlighted the fantastic progress in the work at Braidwood and particularly with the pantry, which is increasing its frequency to every week providing greater capacity for Dumbiedykes residents. Ian noted the pantry work going on as exceptional with the 'Cranny' proving a useful resource as it extends beyond the area.

Sarah advised that the existing Locality Improvement Plans come to an end officially at the end of 2022 but it is intended to recommend to the Edinburgh Partnership that these are extended to 2023 given that the priorities were reviewed and updated in 2020 and in light of the difficulties progressing some areas of work over the last couple of years due to covid. Sarah invited views on this.

Peter highlighted the sub-group within Dumbiedykes where we are beginning to witness increased involvement – it would be good to see if that model can be replicated elsewhere – would support extension of the LIP for that reason.

#### AOB

Sarah explained the imminent changes within the Senior Leadership structure in some parts of the Council and noted that there will no longer be a Locality Manager position. A new post of "Head of Community Empowerment" has been established and is currently being recruited to. There will be a dedicated Community Empowerment team which will support the work of LCPPs moving forward and the wider community planning work at a local level with dedicated officers.

Sarah takes up post as 'Head of Housing Operations' from Feb 1. Evelyn Kilmurry will move to 'Head of Libraries, Sport and Wellbeing'.

Peter noted his thanks to Sarah for her support and commitment over the years and his best wishes for her in her new role.

#### LIP quarterly progress report

Date of LCPP group for consideration: April 2022

Lead officer: Susie Donkin

Priority theme: Employability Update

Actions completed in the last quarter (since the last progress report)

The Participation Measure, which records whether young people aged 16 – 19 are involved in education, training or employment, for February was 90.5% – 0.8%a above the national average. Participation measures for Edinburgh and SIMD areas can be found at: Monthly Participation Snapshot for 16 -19 year olds | Skills Development Scotland

In the recent School Leaver Destination Follow-up - all 5 South East schools improved on previous year — Boroughmuir +2.3, James Gillespies +5.7, Gracemount + 9.2, Liberton +4.3, St Thomas +2.5.

**Skills Development Scotland (SDS)** school delivery in the main across the schools in SE is reasonably on track however, pupil attendance has been sporadic, and this is impacting their work.

The SDS Work Coach is now back delivering face to face in Valley Park Community Centre to young people taking part in NOLB Activity Agreements and school non-attenders group. Also back delivering in Canongate Youth.

SDS recently met with Goodtrees Community Learning to discuss how they can link into groups using the centre.

Relationships with the schools in the locality are very good. Partners are currently preparing for the new cohort of leavers May 22 and are heavily involved in 16 plus arrangements across these schools.

This is no doubt supported by the excellent partnership work with schools, SDS, council and Scottish Government funded employability services and third sector partners.

**Developing Young Workforce (DYW)** continue to offer support to schools to engage industry with education and a breakdown of the support offered in locality schools will be included in the next update.

Appropriate training and support is available to every young person who has left school through the provision of **Activity Agreement Hubs for South East Locality, operated by Dunedin Canmore and Canongate Youth**. Both Hubs continue to engage with a number of young people who have left school without a positive destination, or who have not sustained their college or training place.

The team are able to refer to a wide range of employability provision across the city — especially the projects funded through **Young Person's Guarantee (YPG)** — whilst they continue to support the young people to develop the confidence and skills they need to progress into a positive destination.

The Joined Up for Young People network brings together employability providers across the city to share good practice, promote delivery and discuss progression routes for young people. This network is vital in sharing updates on career management language, key strategies and to help identify gaps in provision which can then be addressed through small grant funding. This also ensure that delivery is available across the city – and accessible in each locality.

The council are delighted to be able to restart the **Edinburgh Project Search** provision in the year ahead. This programme is aimed at young people with a disability or long-term health condition and offers qualifications alongside three x 10 week work placements. Usually hosted by **CEC and NHS Lothian**, we are delighted to confirm the addition of a new partner this year, **Virgin Hotels**. The team will work closely with local employability organisations to promote the programme and to ensure that local young people who are eligible are supported to apply.

#### Milestones expected to be achieved in the next quarter

**Summer school leavers** – partners will work together to ensure that all school leavers without a positive destination is referred to Activity Agreements or signposted to other opportunities across the employability, further and higher education network. The network operates a 'no wrong door' approach, which ensure young people are supported to access whatever services will benefit them.

**A small grant opportunity** - will be offered to third sector organisations to help support the ongoing priorities of YPG and meet any gaps in service that have been identified locally. This is accessible to youth providers as well as those with a track record in employability and training.

#### Barriers/challenges (physical, partnership, financial etc)

Work is still underway to support young people to access services which are beginning to re-open. Mental health of young people has been severely affected by the pandemic, and there is an understanding that young people will take longer and require more support before they are able to progress into a positive destination.

Spring Opportunities Events – the resumption of in-person events have been delayed due to the additional concerns about omicron, staff absence and other delivery priorities. Discussion is underway to ensure that school leavers are supported upon leaving school and officers are investigating how to offer more opportunities locally, rather than in a wider event.



Wider factors/influencers (i.e. legislative changes)

Scottish Government have committed to funding Young Person's Guarantee activity in the year ahead, although the funding amount has been significantly reduced. However,, they have allowed carry forward of funds awarded in 2021-22 which has allowed delivery plans to be developed for the year ahead.

It is hoped that covid restrictions will be further lifted as we move towards spring and that services can resume more face to face work.

#### LIP quarterly progress report

**Priority theme:** Engage with and provide support to those who are sleeping rough, begging and street drinking in the city centre and Southside, working closely with local partners, organisations and communities

Actions completed in the last quarter (since the last progress report)

#### **Hunter Square Working Group**

The Hunter Square Working Group is up and running under the two sub-groups – People and Place involving representation from Police Scotland, CEC, the Simon Community, NHS Lothian, The Access Place at Panmure St Ann's and the University of Edinburgh. Short, medium and long terms plans are being put in place and in addition to extra police presence in the area, vulnerable persons are being signposted to support agencies. Usage of the square is currently being discussed and engagement with local residents and businesses including removal of unused street furniture including phone boxes. Improvement to the look of the area also being considered including floral features and general cleaning of the area has improved resulting in very positive feedback from local businesses. Incidents occurring have dropped substantially however long term solutions are being explored to avoid displacement or the issue returning.

#### **Nicolson Street**

There has recently been an increase into the number of calls received at Nicolson Square involving anti-social behaviour and street drinking, it is believed they are being dispersed from Hunter Square. CPT Officers have been engaging with the people identified to signpost them to other organisations for support but also reminding them of the specific restrictions within the area involving drinking alcohol and enforcing it if required to do so. All local officers have been briefed and patrols will be carried out as often as possible.

#### **Southside Corridor**

On Monday 4<sup>th</sup> and Tuesday 5<sup>th</sup> April 2022 in a joint initiative between Police and Immigration, street beggars in various locations along the Southside Corridor were engaged with. Their immigration status was confirmed and officers made enquires regarding any potential exploitation or welfare concerns. No concerns were highlighted by any of the persons engaged with who were provided with advice and signposted to relevant agencies.

#### **Community Alcohol Partnership**

Officers have been visiting on and off sale premises over the past month to ensure the retailers are complying with licensing requirements and to look out for proxy sales. Advice and literature has been provided to retailers. The dangers of underage drinking has been highlighted to young people in the area via the school link officers and through public engagement. Further events and activities are planning for the upcoming weeks.

#### **Hunter Square Working Group**

As the working group continues, more appropriate uses of the square to be considered including local markets and community events. Following engagement with persons who engage in street drinking in this area, it has been identified they consider Hunter Square to be a 'safe space' for them. Alternative locations providing support being looked into whilst reviewing case studies of similar initiatives used elsewhere.

#### **Operation Taupe**

Following the commencement of the Hunter Square Working Group, a part of the initiative was police presence in the area of Hunter Square and engagement with local businesses and residents. This has resulted in officers dedicated to patrolling this area, speaking to vulnerable persons and offering crime prevention advice to businesses and residents. The Preventions, Interventions and Partnership team have assisted in providing further crime prevention advice to residents. Vulnerable street drinkers have been spoken to with relationships being built. One of the main objectives of the working group was to find out why they frequent this area and it was established it was due to it being felt as a 'safe space'. Ongoing partnership work between police, City of Edinburgh Council, NHS and the third sector continues to identify a suitable safe space location for them to attend and receive the additional support. Outreach work continues with various partners attending the location to offer support. Local off sales licensed premises have also been visited to ensure they are meeting their objectives under the alcohol licence including preventing public nuisance and protecting and improving public health. Feedback is constantly being sought from the local community which has been extremely positive. The issues within Hunter Square are deep rooted & complex and the objective is to avoid displacement and ensure a long term solution is found in supporting vulnerable people and reducing ASB & violence in the area. Operation Taupe will continue working in conjunction with the Hunter Square Working Group.

- · Launch of Food Pantry at the Braidwood Centre with Cyrenians and successfully run to Christmas and subscribed fully. This was a very proactive approach with Braidwood centre who is also opening for groups with Libertus
- · ELGT provided Outdoor groups in the area this quarter. On your door step afternoons meetings on Tuesdays at 1pm outside near The Braidwood Centre with the Cannie an opportunity to come and hear about what is available in the area & a walking group. Also scoping event with face-to-face links in DD area report in 2022
- · Partners delivered a wide range of winter activities. Digital technology and learning online skills (ACE IT Access to Industry) Access to Industry reviving Braidwood Garden activity and looking to link to supporting locality and Gardening as social prescribing with Community link workers

- · Work is ongoing to secure free wifi access for the local community. The Crannie, Greyfriars Charteris Centre and University of Edinburgh continue to take this forward. University have funding for a PhD intern for 5 hours per week to support the subgroup in setting up free wifi for the area.
