1. Minutes

The note of the previous meeting was approved as an accurate record.

2. Tracker

The action tracker will be updated.

3. LIP Development – Update

Michael advised that the LIP Development Sub-Group had agreed that 3 engagement sessions would be held.

- Goodtrees Neighbourhood Centre – 9 November
- Southside Community Centre – Date TBC
- A Police Scotland lead session – Date and Venue TBC

There was some discussion around appropriate venues with suggestions including University of Edinburgh, The Charterist Centre, Grassmarket Project and The Crannie. The sub-group had looked at how to involve the Dumbiedykes group who do not meet again until into the new year, they will be invited to attend all sessions.

4. Community Grants Fund – update (CGF)

Michael gave an update on the four SE CGF funds.

- City Centre – fully allocated
- Liberton/Gilmerton – oversubscribed
- Southside/Newington – oversubscribed
- Morningside – undersubscribed

Michael reported that he would be focussing on promotion of the fund in Morningside.

Jackie added that the team are compiling a report on CGF at present to allow for scrutiny of areas including spend, funding panels and applicants.

There was some general discussion around available funds in the city including the NHS Lothian Charitable Trust, Edinburgh University small

grants fund, Children and Families Connected Communities grant fund – closing date 1 November.

Lucy highlighted the IVAR UK grant making website which offers tips on promoting and disbursing grants and Ian reminded people of the Edinburgh4Community funding search site.

Braidwood Centre – Jackie reported that it has not yet been leased as elements of the lease are sitting with the Council legal team, it is hoped that it will be open by the end of the year. In the meantime, Jackie is having the garden area tidied.

5. Membership of LCPP

Michele advised that a stocktake of LCPP membership across the City will be carried out. There is concern about lack of community representation where Neighbourhood Networks are not functioning, and no rep has been nominated. Michele explained that LCPPs do have the option to co-opt members, and queried if this could be a solution in the short-term while the Empowerment and Engagement Team work with NNs.

6. Edinburgh Partnership Update

Michele reported that the September EPB focussed on 2 areas. Actions to address poverty, homelessness and wider prevention of poor health and wellbeing. This included presentations on the Prevention Duty, The Early Intervention and Prevention Strategy and the Poverty Plan. The other area of focus was the Development of an Edinburgh Partnership Transformation and Improvement Programme which will enable the Partnership to address current challenges, whilst seeking to strengthen the delivery of the priorities through identifying opportunities for transformation and long-term collaboration. A plan will go back to the Board in March or June 2024 around this.

Michele added that the results of the first Edinburgh Partnership survey had been received. These can be drilled down to Ward level. They will be presented to the EPB in December and thereafter could come to a meeting of the LCPP.
