Helen advised that the Empowerment and Engagement Team will support the process but it requires buy-in from the LCPP. Michele added that there is an overarching project plan, this would be updated and circulated to the LCPP.

It was highlighted that it is key to consider 'harder to reach' groups and this would be a point of consideration for the sub-group.
